Include the G-28 or release form from the child (and sponsor) with the CRCL complaint at: <https://www.dhs.gov/file-civil-rights-complaint>, email the [CRCLCompliance@hq.dhs.gov](mailto:CRCLCompliance@hq.dhs.gov), or fax a complaint at 202-401-4708
  - Families, attorneys, and social service providers can also reach out to ICE about any family separation concerns (in particular primary caregivers): *Always reference "Parental Interests Inquiry."* Contact ICE field offices by sending them an email <http://www.ice.gov/contact/ero> or completing this form <http://www.ice.gov/webform/ero-contact-form>. If no response, call the DRIL hotline: 1-888-351-4024
  - If you believe an unaccompanied child is in immediate danger/risk call **Child Protective Services**.
